GENERAL INFORMATION AND INTRUCTIONS FOR BIDDERS

Introduction

Jila Sahakari Kendriya Bank Maryadit Jagdalpur is located in the southern region of Chhattisgarh state. The bank was established in the year 1949. The working area of the bank covers 7 districts of Bastar division. At present the bank is providing modern banking facilities through its 01 Head Office and its 46 branches 08 ATM and 04 Micro ATM Vans. in addition to these establishments we are in process of deploying 33* more ATM Machines in different areas of Bastar Division.

Mobile ATM vans are to be deployed by the bank for the purpose of providing digital / modern banking facilities to farmers/account holders of the bank located in remote and difficult to reach villages of Bastar and Narayanpur districts. For which fabrication and modification work is to be done in Mahindra Bolero Camper Gold ZX mobile ATM vans so that the present and future needs can be met.

Objective

The objective of this tender is to select and finalize the vendor for Fabrication/Modification of Mahindra Bolero Camper Gold ZX mobile ATM vans for providing digital / modern banking facilities to farmers/account holders of the bank located in remote and difficult to reach villages of Bastar and Narayanpur districts.

Instruction to fill & submit the Tender Document:

SCOPE OF WORK, DELIVERABLES AND TIMELINES

1. Details of Work

The successful bidder will be responsible for Fabrication/ Modification of Mahindra Bolero Camper Gold ZX mobile ATM Vans with ATM solutions as per need of Bank. The integration of the Mobile Van with ATM solutions with Bank's CBS & other systems and interface with respective Payment Gateways & other interfaces will be the responsibility of the bidder.

The ATM and Network Connectivity will be provided by Bank.

The scope of work for Mobile ATM Van:

The Bank has installed an Electronic Financial Transaction Switch to drive and administer ATMs of the Bank. The Mobile Van ATMs will be integrated with bank's switch

- 1.1 Supply, installation, testing and commissioning of Mobile Van.
- 1.2 Selected vendor has to provide designs for fabrication on vehicle to Bank. The appropriate design will be approved by Bank and vehicle shall be fabricated as specified by the Bank with reinforced body for mounting ATM.
- 1.3 Supply, installation, testing and commissioning of network, UPS, lighting arrangements etc. to facilitate transactions through Mobile ATMs.
- 1.4 DVR/CCTV image capturing while transacting on ATM.
- 1.5 Van should power backed up.
- 1.6 Customized External Graphics with Organization Name, Address, Logo etc as per the design provided by you.
- 2. Integration of supplied goods, equipment's & software

The bidder must integrate all the hardware equipment(s), vehicle and software components to make the mobile van system integrated and fully functional. It will be bidder's responsibility to locate the exact nature of the problem / fault(s) and rectify the same. Bidder should guarantee that all components are new.

ELIGIBLITY CRITERIA

- The tenders should be in two separate envelopes Technical and Commercial completely sealed and later in one common envelope completely sealed.
- Bidder should have experience of supplying all items and will have to furnish details of previous supplies.
- The bidder should not be black listed company in any of the government institution / bank, the self-declaration in this regard on company's letter head should be attached to the technical proposal.

Tender Rejection Criteria:

- 1. The bidder's details attached to tender are not found as per eligibility criteria.
- 2. Technical and commercial offers found in one envelope.
- 3. Non -indexed documents attached to tender document.
- 4. Tenders without Tender Document Fees or EMD Pay Order or DD.
- 5. Tender submitted with false and wrong information.
- 6. Information requested by DCCB for this tender process is not found in Technical and commercial offer.
- Misconduct and influence if any to this tender process by the bidder or its representative/s will result into rejection of bid document. No further communication will be entertained in this regard.

- 4. The tender should be quoted as per the given format, no changes should be made in this tender document. The vendor is not liberal to quote for new technical solutions or specifications separately.
- Sealed tender must reach Head Office on or before 06/01/2023 up to 02:00
 P.M. Tender received after due date & time will not be accepted. Postal / courier delays will not be accepted.
- 6. Proposal submitted by E-mail or any other similar manner will not be accepted.
- 7. Proposals may not be withdrawn after submission and shall be valid for a period of 90 days.
- 8. Proposals must in organized, structured and indexed manner. Brochures/ leaflets and other documents with index. If not organized and documents not found at the time of tender scrutiny, bank will reject the tender. No communication in this regards will be entertained.
- Vendors must identify by name, title, and telephone number of the person(s)
 in their organization to whom Bank can address questions during the
 evaluation of proposals.
- 10. An authorized officer of the vendor shall sign proposal(s) (supported by appropriate documentation). Any erasures or other changes included on any project submission shall bear the signature of the authorized officer only.
- 11. The proposal should be complete in all respects and contain all information asked for, along with all the technical/product details. The proposal should include all items asked for in the attached Annexure. Impression of company seal is required on each page of this tender document and same should signed by company's authorized representative.



- 12. Each page of original tender document must duly sign & stamped as a token of acceptance of terms & condition. Original Tender Document must be submitted along with the offer, otherwise the tender will be rejected.
- 13. If, in the opinion of Bank, a proposal /quote/ documents contain false or misleading statements or references that do not support a function, attribute, capability or condition as contended by the vendor, it shall be rejected.
- 14. The terms and conditions applicable to any resulting contract are those contained herein. Any different or additional terms contained in bidder's purchase order acknowledgement or other document, are unacceptable to Bank and may be rejected.
- 15. The bank reserves the right to enter into a contract based upon proposals received without further discussion on such proposals. Accordingly, proposal should be submitted with the vendor's best and competitive price, delivery and service capabilities. Bank may/if require, will negotiate on price with vendor/s.
- 16. EMO retention period up to one year from the date of the purchase order. The EMO will carry no interest.
- 17. The EMO of the unsuccessful Bidder shall be refunded after final acceptance of the tender and within reasonable time not exceeding six months from the date of opening of the tender. The EMO will carry no interest.
- 18. The EMO will be forfeited if a Bidder withdraws his offer before finalization of the tender. The EMO of the successful Bidder shall also be forfeited if the Bidder fails to supply fabricated Van within specified period.
- 19. The other components listed on Annexure 1 should have One Year Comprehensive On-site warranty which shall be applicable from the date of installation.
- 20. Process of Tender
- a) Tenders will be opened in front of bank's Tender Committee and Management staff. An authorized representative of vendor can be present. At the time of opening, bank will open main envelope containing Technical and Commercial bids. Post that, only Technical offer, Tender Fees and EMO envelope will be opened. The first scrutiny and selection of eligible vendors for next process will be based on the documents submitted along with tender document.
 - The Bank will first scrutinize technical offers submitted by vendor to determine whether they are complete and matching with the eligibility criteria and conditions mentioned in tender document.

- c) Post scrutiny of offers/tenders, bank will inform eligible for negotiation or any decision that bank may take.
- d) The non-eligible vendors will be informed by fax /e-mail/postal service, EMD of all such vendors will be returned back.
- e) The commercial proposal of only technically eligible vendor/s will be opened in front of bank's Tender Committee and Management staff. An authorized representative of vendor can be present.
- 21. Any publicity by the vendor in which the name of bank is to be used should be done only with the explicit written permission of the bank.
